#### **COURSE DESCRIPTION**

Continuation of beginning level of classical guitar ensemble performance at public events.

## 1. COURSE GOALS

- 1.1 Develop an outstanding ensemble, skilled in performance techniques and capable of a higher level of performance of guitar ensemble music
- 1.2 Provide special opportunities for each individual, including solo opportunities and select guitar literature for the highly qualified
- 1.3 Provide an exciting and challenging musical experience for the performer and listener
- 1.4 Acquaint all participants with the potential for artistic performance
- 1.5 Attain maximum results in minimum time
- 1.6 Acquaint participants with classical guitar ensemble literature
- 1.7 Further develop sight reading skills

## 2. OUTCOMES

Upon satisfactory completion of this course, students will be able to:

- 2.1 display a higher degree of mastery of classical guitar ensemble literature
- 2.2 display a higher level of comfort in the guitar ensemble setting
- 2.3 perform public concerts
- 2.4 demonstrate and display a higher level of artistic performance
- 2.5 demonstrate a more in-depth knowledge of classical guitar ensemble and solo literature
- 2.6 demonstrate further improvement in the ability to sight read

#### 3. METHODS OF INSTRUCTION

Instruction of the highly integrated skills, techniques and concepts of music will follow standard methods of rehearsal

## 4. <u>LEARNING ACTIVITIES</u>

- 4.1 Each class will be a rehearsal setting
- 4.2 New music will be studied and learned
- 4.3 Learned music will be rehearsed to improve artistic performance
- 4.4 Concepts and skills for artistic performance will be taught

- 6.5 Texts and Notebooks: Students are required to obtain the class materials for the course.
