### PREREQUISITE: MAT 187; MAT 183 and MAT 151; or an approved higher-level math course

### COURSE DESCRIPTION

Introduction to motion and interactions that change motion; introduction to mechanical energy, momentum, fluids, thermodynamics, and waves.

- 1.2 Engage students in scientific inquiry by constructing knowledge through observation.

Upon completion of this course, students will be able to:

- 2.1 analyze changes in a system's position, velocity, momentum, and mechanical energy due to interactions between the system and its environment.
- 2.2 analyze the behavior of fluid systems.
- 2.3 analyze the behavior of thermal systems.
- 2.4 analyze the behavior of mechanical waves.
- 2.5 collect information about a physical system by observation and measurement.
- 2.6 communicate information about a physical system.
