COURSE DESCRIPTION

Introduction to mechanics. Analysis of the interactions between a system and its environment to determine changes in the system's position, velocity, momentum, and mechanical energy. Application of Newton's laws and conservation laws to the behavior of physical systems.

1. COURSE GOALS

- 1.1 Engage students in collecting, analyzing, and communicating information about physical systems.
- 1.2 Engage students in scientific inquiry by constructing knowledge through observation.
- 1.3 Engage students in developing skills adaptable to changing environments by applying physics principles in a variety of situations.

Upon completion of this course, students will be able to:

- 2.1 identify and classify the interaction forces acting on a system.
- 2.2 represent the forces acting on a system using free-body and force-vector diagrams.
- 2.3 determine the net force acting on a system.
- 2.4 analyze changes in a system's position, velocity, momentum, and mechanical energy due to interactions between the system and its environment.
- 2.5 collect information about a physical system by observation and measurement.
- 2.6 communicate information about a physical system.

7. STUDENT RESPONSIBILITIES
