PIT 103 IT Support: System Administration

Credit Hours: 2 Lec 2 Lab 1

PREREQUISITE: None

COURSE DESCRIPTION:

Students will learn about systems infrastructure and the services that keep organizations operational. The course content will cover cloud infrastructure, managing cloud resources, managing and configuring servers, the use of industry tools to manage computers, user information, and user productivity, as well as how to recover an organization's IT infrastructure.

1. COURSE GOAL

Prepare student for an entry-level role in IT support with focus on system administration and IT infrastructure services.

2. OUTCOMES

Upon satisfactory completion of this course, students will be able to:

- 2.1 utilize best practices for selecting hardware, vendors, and services for an organization
- 2.2 demonstrate an understanding of the most common infrastructure services and how to manage infrastructure servers
- 2.3 demonstrate an understanding of how to maximize cloud services for an organization
- 2.4 demonstrate the ability to manage an organization's computers and users utilizing the directory services, Active Directory, and OpenLDAP
- 2.5 identify and describe the management tools an organization will utilize
- 2.6 demonstrate the ability to backup an organization's data and how to recover an organization's IT infrastructure in the case of a disaster
- 2.7 utilize systems administration knowledge to plan and improve processes for IT environments

6. STUDENT RESPONSIBILITIES
