PLS 211 Soils/GE Credit Hours: <u>4</u> Lec <u>3</u> Lab <u>3</u>

PREREQUISITE: None NOTE: PLS 100 or other 100 level science course recommended

COURSE DESCRIPTION

Fundamental principles of soil science, the origin, nature and classification of soils, the chemical, physical and biological properties in relation to growth and nutrition, and problems of saline soils.

1. <u>COURSE GOAL</u>

This course prepares learners to correlate soil properties with plant growth and make recommendations regarding nutrient availability, crop water requirements and basic soil management.

- Upon satisfactory completion of this course, students will be able to:
- 2.1 identify and demonstrate the basic principles of soil-plant relationships.
- 2.2 identify soil constituents, history and formation processes.
- 2.3 identify the nature and significance of soil colloids.
- 2.4 identify the physical properties of soil and the necessary management practices.
- 2.5 describe the significance and economics of soil organic matter.
- 2.6 explain the management schemes of soil water and aeration.
- 2.7 explain the significance of soil microflora in terms of plant growth.
