PLS 230 BASIC SOIL FERTILITY

Credit Hours: 3 Lec

PREREQUISITE: None

COURSE DESCRIPTION

An introduction to plant fertility, including fertilizer interactions with soil, water, and general conditions found in crop production, as well as forms of fertilizer, availability, and functions in plant growth.

1. COURSE GOALS

- 1.1 Understand the interaction of fertilizer forms in the soil solution: availability, the loss and conversion of nutrients and function in plant processes.
- 1.2 Know and understand the application techniques used in production agriculture.
- 1.3 Understand the relationship of soil moisture and fertilizer availability.

2. OUTCOMES

- Upon satisfactory completion of this course, students will be able to:
- 2.1 differentiate the relationships of fertilizer forms and availability.
 - 2.2 describe the interaction of essential nutrients in the plants.
 - 2.3 calculate the amount of fertilizer and materials needed for a given crop.
 - 2.4 assess the environmental impact of applied fertilizer and its fate in the cropping system, including surface and groundwater.
 - 2.5 explain the concept of Best Management Practices for fertilizer recommendations.
 - 2.6 describe and assess the impact of cultural practices and fertilizer applications on soil health and structure.
 - 2.7 evaluate the integration of new technologies on fertilizer recommendations.
