POS 120 WORLD POLITICS/GE

Credit Hours: 3 Lec 3 **SUN** # POS 120

COURSE DESCRIPTION

This course explores the existence of a world-wide political system and what that system means to individuals. It reviews agencies and personalities of foreign policy and attempts at international organizations, such as the United Nations.

1. **COURSE GOALS**

- Identify the nation-states of the world and the various blocs and regional areas into which they 1.1 fall.
- 1.2 Describe the resources owned or controlled by various nation-states.
- 1.3 Predict the direction in which world politics are taking us and what the future may hold in that respect.

Upon satisfactory completion of this course, students will be able to:

- 2.1 survey the political map of the world and the various international blocs, alliances, and organizations through which the nations of the world communicate.
- review the "ecology" of world politics, including attention to environmental, population, and 2.2 resource problems contributing to, or brought on by, existing political arrangements in the world.
- 2.3 discuss where the world political system may be going in the future.
- explore some of the more prominent hypotheses developed by philosophers and social scientists in 2.4 regard to the world political system.
- 2.5 generate appropriate writing discourse according to the AWC Writing Intensive Courses: General Education guidelines.
