PSY 270 SOCIAL PSYCHOLOGY

Credit Hours: 3 Lec 3

General Education Course: C (Ethnic, Race, Gender Awareness)

PREREQUISITE: PSY 101 or SOC 101

COURSE DESCRIPTION

Explores the combined areas of psychology and sociology, with emphasis on the reciprocal interaction of individuals and their groups. Areas covered include methods of social research, basic psychological factors, social attitudes, communication, society and culture, and small groups.

1. COURSE GOALS

- 1.1 Understand the impact of the individual on group functioning.
- 1.2 Illustrate the effects of the group on the individual by applying various examples.
- 1.3 Apply research method to journal articles, book chapters, and their own lives.
- 1.4 Illustrate concepts such as attitude formation, beliefs, bias, obedience, prejudice, and compliance.

2. OUTCOMES

Upon satisfactory completion of this course, students will be able to:

- 2.1 define Social Psychology.
- 2.2 define terms central to Social Psychology.
- 2.3 present a lecture on an area of interest in Social Psychology.
- 2.4 illustrate concepts of Social Psychology.
- 2.5 work in groups to discuss concepts.
- 2.6 work together to describe concepts to one another.
- 2.7 explain how Social Psychological concepts apply to their own life.
- 2.8 think critically about psychological "facts".

6. STUDENT RESPONSIBILITIES
