RAD 100 INTRODUCTION TO RADIOGRAPHY AND PATIENT CARE Credit Hours: <u>2</u> Clin <u>12</u>

PREREQUISITE: Full acceptance into the Radiologic Technology Program

COURSE DESCRIPTION

This course introduces the fundamentals of radiologic science, the radiologic technology program, and the health care system.

1. <u>COURSE GOAL</u>

To introduce the learners to the field of radiography and issues that are unique to the health care system.

2. <u>OUTCOMES</u>

Upon satisfactory completion of this course, students will be able to:

- 2.1 Discuss general principles of radiation protection.
- 2.2 Discuss the components of the Radiation Safety Policy as stated in the Radiologic Technology Student Guide and as applied in the clinical setting.
- 2.3 Identify major duties/responsibilities of a student radiographer.
- 2.4 Define accreditation, institution versus programmatic, credentialing, certification, registration, licensure, and regulations.
- 2.5 Define key positioning terms used during radiographic examinations.
- 2.6 Apply appropriate infection control techniques in the healthcare environment
- 2.7 Operate diagnostic radiography equipment.
- 2.8 Explain legal terms, principles, doctrines, and laws specific to the radiologic sciences.
- 2.9 Discuss the American Society of Radiologic Technologists (ASRT) Scope of Practice for the radiographer and describe elements that comprise it.
- 2.10 Define informed consent, and describe the essentials for valid informed consent.
- 2.11 Discuss the ASRT Code of Ethics.
