# RAD 102 RADIOLOGIC TECHNOLOGY PORTFOLIO DEVELOPMENT 2

Credit Hours: 4 Lec 1 Clin 18

PREREQUISITE: Completion of standard prerequisites needed for entrance into the Radiologic Technology Program. Program Director's approval is needed for entry into this course.

NOTE: RAD 102 maybe equivalent to one or more RAD courses with instructor approval

## COURSE DESCRIPTION

This course allows students seeking reentry into the Radiologic Technology Program to demonstrate competency in previously completed diagnostic exams or to repeat one academic course. Credit/No Credit.

#### 1. COURSE GOAL

- 1.1 Documents continued competency of reentering students on competency examinations completed prior to exiting the program.
- 1.2 Allows the student to rotate through clinical sites to practice exams and to manipulate equipment.

#### 2. OUTCOMES

Upon satisfactory completion of this course, students will be able to:

- 2.1 demonstrate competency by simulation and rechecks of all exams completed up to the date of exit from the program
- 2.2 repeat course work (one academic radiologic technology course only)
- 2.3 articulate with the current radiologic technology class at a level that is above or equal to the current class.

# 6. <u>STUDENT RESPONSIBILITIES</u>
