SGT 120 SURGICAL TECH FOUNDATIONAL SKILLS

Credit Hours: 5 Lec 3 Lab 4

PREREQUISITE: Admission into Surgical Tech program

COREQUISITE: SGT 110, SGT 130, & SGT 140

COURSE DESCRIPTION

This course provides theoretical knowledge for the application of essential operative skills during the perioperative phase. It introduces the student to the practice of surgical technology with a focus on those skills necessary for function in the first scrub role. This course will be taught as lecture in conjunction with an active hands-on college laboratory component. Topics include surgical asepsis, sterilization and disinfection and perioperative patient care.

1. COURSE GOAL

To introduce students to the basic skills required for successful functioning in the surgical environment as well as the development of the understanding of the principles behind the practice.

2. OUTCOMES

Upon satisfactory completion of this course, students will be able to:

- 2.1 Demonstrate and discuss the principles of aseptic technique.
- 2.2 Demonstrate and discuss the principles of scrubbing, gowning and gloving.
- 2.3 Demonstrate and discuss the principles of skin preparation.
- 2.4 Demonstrate and discuss the principles of sterile draping methods.
- 2.5 Demonstrate and discuss case preparation, including instrumentation, sutures and surgical supplies and equipment.
- 2.6 Discuss the normal progression of surgical procedures from preparation, beginning, intraoperative and ending.

6. STUDENT RESPONSIBILITIES
