SGT 130 SURGICAL PROCEDURES I

Credit Hours: 5 Lec 3 Lab 4

PREREQUISITE: Acceptance into Surgical Tech Program

COREQUISITE: SGT 110, SGT 120, & SGT 140

COURSE DESCRIPTION

This is an orientation to specific surgical specialties including General surgery, surgery of the gastrointestinal tract, biliary system, gynecology, urology, and surgery of the ear, nose and throat. This course intends to introduce the student to each anatomical system with a focused review of pathology in conjunction with those specific procedures performed. The instrumentation and surgical modalities of each specialty will be discussed as it relates to the practice of Surgical Technology.

1. COURSE GOAL

To provide the student with individualized experience in practice in the field. Emphasis is placed on demonstrating proficiency in skills necessary for participation in basic surgical procedures.

2. OUTCOMES

Upon satisfactory completion of this course, students will be able to:

- 2.1 Discuss the relevant anatomy of the body systems related to general, gastrointestinal, gynecological, ear, nose & throat and urological surgery.
- 2.2 Describe the pathology that prompts surgical intervention.
- 2.3 Discuss preoperative diagnostic tests and preparations.
- 2.4 Identify the names and uses of instruments, supplies and drugs pertinent to each body system
- 2.5 Identify the names and uses of specialized equipment for each system.
- 2.6 Analyze the role of the surgical technologist during interventional radiology procedures, including the use of imaging modalities, radiation safety principles, and sterile technique within the interventional radiology environment.
- 2.7 Differentiate oral and maxillofacial surgical procedures, anatomy, instrumentation, and perioperative considerations associated with craniofacial, dental, orthognathic, and reconstructive surgical interventions.

6. STUDENT RESPONSIBILITIES
