# ARIZONA WESTERN COLLEGE SYLLABUS

SOC 170 HUMAN SEXUALITY/GE (same as PSY 170) Credit Hours: 3 Lec 3

PREREQUISITE: Students must be 18 years old at the time the class starts; PSY 101, SOC 101, or SOC 160 recommended.

# COURSE DESCRIPTION

Coverage and candid discussion of various aspects of human sexuality including history of sexual values, sexual physiology, life span changes, sexual roles and gender identity, sexual diseases and dysfunctions, contraception and abortion, sexual assault, and pregnancy and birth.

## 1. COURSE GOAL

- 1.1 Increase awareness and appreciation of different views concerning sexuality in relation to one's gender, age, sexual orientation, and religious, racial and/or ethnic background.
- 1.2 Facilitate open and honest communication about sexuality.
- 1.3 Gain a better understanding of themselves and their individual effect on any relationship.
- 1.4 To promote students' recognition of their own particular needs as maturing persons in our society today.

## 2. COMPETENCIES

Upon satisfactory completion of this course, the student will be able to:

- identify trends and changes in the past and present that influenced sexual attitudes and values of themselves and others in the United States and be aware of how some of these values differ from those in other cultures.
- 2.2 identify various parts of their sexual anatomy and be aware of how these parts function.
- 2.3 interact with others on a social and sexual basis to achieve fulfilling relationships.
- 2.4 know the various sexual diseases and dysfunctions, how their risk can be minimized, and how they can be dealt with if they occur.
- 2.5 know about methods of contraception and abortion and be aware of their own standards and values related to these issues.
- 2.6 know about various types of unconventional sexual behavior, the factors that contribute to this behavior, and why they are considered unconventional.
- 2.7 know the reasons for, and the effects of, commercial sex (prostitution and pornography).
- 2.8 understand the causes of sexual assault, how to minimize the probability of such assault, and what to do after an assault has occurred.
- 2.9 understand the changes that occur in a woman during pregnancy and birth and how these changes affect her interactions with others.
