PREREQUISITE:  
Completion of SPA 101 or SPA 095

COURSE DESCRIPTION

Intercambio/Conversation Exchange focuses on true conversational practice of English and Spanish between native Spanish speakers and native English speakers. Students of each language background will practice their target language with native speakers in groups and/or pairs.

Improve oral proficiency in Spanish for native English speakers

6. STUDENT RESPONSIBILITIES

- 6.1 Under AWC Policy, students are expected to attend every session of class in which they are enrolled.
- 6.2 Classroom Assignments: Students are responsible for work missed and for completing all work before the next class meeting. Students are responsible for participating in all oral drills and for taking all exams.
- 6.3 If a student is unable to attend the course or must drop the course for any reason, it will be the responsibility of the student to withdraw from the course. Students who are not attending as of the 45th day of the course may be withdrawn by the instructor. If the student does not withdraw from the course and fails to complete the requirements of the

course, the student will receive a failing grade.

Students who have enrolled but have never attended class may be issued a “No Show” (NS) grade by the professor or instructor and receive a final grade of “NS” on their official academic record. An NS grade may result in a student losing their federal financial aid.

- Initiating contact with a faculty member to ask a question about the academic subject studied in the course
