SPA 101 ELEMENTARY SPANISH 1/GE

Credit Hours: 4 Lec 4 SUN# SPA 1101

PREREQUISITE: None

NOTE: This course is not designed for native Spanish speakers or students with intermediate proficiency or better.

COURSE DESCRIPTION

Basic communication skills with emphasis on oral communication and elementary grammar. Students are exposed to the culture and traditions of the Spanish-speaking countries. Fulfills the first semester foreign language requirement at most four-year institutions.

COURSE GOALS 1.

- 1.1 Develop a solid foundation for listening and speaking.
- Introduce reading and writing, and, although not emphasized, develop these skills. 1.2
- Develop an interest in continued study of Spanish. 1.3

- 2.2 write simple paragraphs using familiar material.
- 2.3 recognize and explain everyday cultural patterns.
- 2.4 demonstrate understandable pronunciation skills when speaking and engaging in conversation, provide and obtain information, express feelings and emotions, and exchange opinions in highly predictable everyday settings.

Arizona Western College students are expected to attend every class session in which they are enrolled. To comply with Federal Financial Aid regulations (34 CFR 668.21), Arizona Western College (AWC) has established an Attendance Verification process for "No Show" reporting during the first 10 days of each semester.
