PREREQUISITE: SPA 101

COURSE DESCRIPTION

A continuation of Spanish 101. Basic communication skills with emphasis on oral and elementary grammar. Fulfills the second semester foreign language requirement at most four-year institutions.

1. COURSE GOALS

- 1.1 Continue to build on listening and speaking skills initiated in Elementary Spanish 101.
- 1.2 Continue to develop reading comprehension and improve writing skills.
- 1.3 Appreciate traditions and cultures of Spanish speaking countries
- 1.4 Develop an interest in continued study of Spanish.
- 1.5 Develop ethnic, race, and gender awareness.

2. OUTCOMES

Upon satisfactory completion of this course, students will be able to:

- 2.1 identify important facts in a text through reading.
- 2.2 write paragraphs using familiar material.
- 2.3 recognize and explain everyday cultural patterns.
- 2.4 demonstrate understandable pronunciation skills when speaking and engage in conversation, provide and obtain information, express feelings and emotions, and exchange opinions in highly predictable everyday settings.

7 STUDENT RESPONSIBILITIES

- 7.1 Under AWC Policy, students are expected to attend every session of class in which they are enrolled.
