PREREQUISITE: SPA 102

COURSE DESCRIPTION

A continuation of SPA 102 with emphasis on oral communication. Listening and reading comprehension, with writing exercises, are integrated to develop and reinforce intermediate speaking skills. Modern-day topics for discussion provide a conversational approach to learning Spanish. Fulfills the third semester foreign language requirement at most four-year institutions.

1. COURSE GOALS

- 1.1 Continue to build on listening and speaking skills initiated in Elementary Spanish 101-102.
- 1.2 Continue to develop reading comprehension and improve writing skills.
- 1.3 Present modern-day topics and everyday activities for discussion.
- 1.4 Present the activities, traditions, and culture of the Spanish-speaking world.
- 1.5 Develop ethnic, race, and gender awareness.

2. OUTCOMES

Upon satisfactory completion of this course, students will be able to:

- 2.1 summarize, in their own words, a text through reading.
- 2.2 write short compositions using familiar material.
- 2.3 recognize and explain cultural patterns.
- 2.4 communicate and demonstrate understandable pronunciation and comprehension skills when speaking in varied situations
- 2.5 present information, concepts and ideas on a variety of topics.

- 5.5 View multimedia on Hispanic cultures
- 5.6 Write a paper (minimum 500 words) on some phase of Hispanic culture

- 6.2 Written assignments

- 6.4 Participation
- 6.5 Paper on Hispanic culture

## 7. STUDENT RESPONSIBILITIES

- 7.1 Under AWC Policy, students are expected to attend every session of class in which they are enrolled.
- 7.2 If a student is unable to attend the course or must drop the course for any reason, it will be the responsibility of the student to withdraw from the course.
