# PREREQUISITE: SPA 201

#### COURSE DESCRIPTION

A continuation of Spanish 201 with emphasis on oral communication. The course provides a way to practice Spanish in a communicative context through reading selections on Hispanics' customs and traditions. Writing exercises provide a review of grammar. Fulfills the fourth semester foreign language requirement at most four-year institutions.

# 1. COURSE GOALS

- 1.1 Enrich the student with an atmosphere to practice all language skills (reading, writing, speaking, and listening).
- 1.2 Learn about the different Spanish speaking countries.
- 1.3 Acquire knowledge about the people who speak the language; how they live, and how many things we have in common.
- 1.4 Help the student to enrich his own culture by making comparisons of Spanish-speaking people and integrating their knowledge into his own world.
- 1.5 Develop ethnic, race, and gender awareness.

#### 2. OUTCOMES

Upon satisfactory completion of this course, students will be able to:

- 2.1 summarize, in their own words, a text through reading.
- 2.2 write short compositions using familiar material.
- 2.3 recognize and explain cultural patterns.
- 2.4 communicate and demonstrate understandable pronunciation and comprehension skills when speaking in varied situations
- 2.5 present information, concepts and ideas on a variety of topics.

#### STUDENT RESPONSIBILITIES
