SPA 251 INTERMEDIATE SPANISH GRAMMAR AND COMPOSITION/GE

Credit Hours: 3 Lec 3

PREREQUISITE: SPA 202 or 204

COURSE DESCRIPTION

Intermediate-high grammar, reading comprehension, composition and translation, including class conversations, and debates which are integrated to develop and reinforce academic speaking and written skills.

1. COURSE GOALS

- 1.1 Strengthen academic Spanish grammatical concepts.
- 1.2 Continue building on academic listening and speaking skills.
- 1.3 Practice reading comprehension and improve academic writing skills.
- 1.4 Expose students to modern-day topics and everyday activities for discussion.
- 1.5 Demonstrate above stated skills in an academic composition.

2. OUTCOMES

Upon satisfactory completion of this course, students will be able to:

- 2.1 follow the writing process (organizing, revising, and proofreading) in order to create essays in Spanish.
- 2.2 write paragraph-length narrative and descriptions in all major time frames (past, present and future).
- 2.3 summarize a written text.
- 2.4 identify, analyze, and explain cultural patterns.
- 2.5 Communicate clearly using appropriate Spanish pronunciation in varied situations.
- 2.6 deliver a formal, oral and visual presentation to diverse audiences.
- 2.7 write a 1,000-word composition in academic Spanish with proper citation and integrations of ideas from other sources.
- 2.8 apply major grammatical conventions of academic Spanish meaningfully.

7. STUDENT RESPONSIBILITIES
 - 7.1 Under AWC Policy, students are expected to attend every session of class in which they are enrolled.
 - 7.2 If a student is unable to attend the course or must drop the course for any reason, it will be the responsibility of the student to withdraw from the course.
