ACC 115 COMPUTERIZED ACCOUNTING

Credit Hours: 3 Lec 3

PREREQUISITE: ACC 100 or higher-level accounting course

COURSE DESCRIPTION

Course applies accounting principles using a commercial accounting software program. Professional accounting computer software will be utilized to simulate the setup of accounting books, enter daily transactions, and prepare financial statements for small businesses.

1. COURSE GOAL

Using the accounting software program, the student will set up several types of business entities completing the accounting cycle. The student will complete the accounting cycle through the preparation of external and internal financial statements from the accounting software program.

Upon satisfactory completion of this course, students will be able to:

- 2.1 set up a company in an accounting software program including the creation of a chart of accounts.
- 2.2 complete accounts receivable transactions including billing customers and depositing receipts.
- 2.3 complete accounts payable transactions including posting invoices to appropriate accounts and rendering payment to vendors.
- 2.4 complete payroll transactions including accurate calculations of taxes and withholdings as well as applying payroll costs to jobs.
- 2.5 prepare end of period accrual entries through journaling.
- 2.6 perform the bank reconciliation for cash accounts.
- 2.7 journal entries for a service, merchandise company, and job-costing.
- 2.8 prepare and interpret external and internal financial reports including end of period financial statements.

6. STUDENT RESPONSIBILITIES
