ACC 295 ACCOUNTING CAPSTONE

Credit Hours: 3 Lec 3

PREREQUISITE: ACC 212

## **COURSE DESCRIPTION**

A course designed to allow the student to apply the concepts learned in the accounting certificate or degree program. The student will complete either an internship in a supervised work experience in professional accounting, or a comprehensive project.

## 1. COURSE GOALS

1.1 Apply classroom concepts in an accounting environment.

## 2. OUTCOMES

Upon satisfactory completion of this course, students will be able to:

- 2.1 application of accounting concepts learned in certificate or degree program.
- application of critical thinking skills to moderate accounting concepts, business problems and ethical dilemmas.
- 2.3 effective use of technology.
- 2.4 proficiency in oral/written business communication.
- 2.5 learn time management skills required in business to complete tasks within deadlines while multi-tasking.

# 3. STUDENT RESPONSIBILITIES

- 3.1 Under AWC Policy, students are expected to attend every session of class in which they are enrolled.
- 3.2 If a student is unable to attend the course or must drop the course for any reason, it will be the responsibility of the student to withdraw from the course. Students who are not attending as of the 45<sup>th</sup> day of the course will be withdrawn by the instructor. - 3.6 Arizona Western College students are expected to attend every class session in which they are enrolled. To comply with Federal Financial Aid regulations (34 CFR 668.21), Arizona Western College (AWC) has established an Attendance Verification process for "No Show" reporting during the first 10 days of each semester. Students who have enrolled but have never attended class may be issued a "No Show" (NS) grade by the professor or instructor and receive a final grade of "NS" on their official academic record.
