COURSE DESCRIPTION

Introduces the history of Reiki as a healing art. Presents an understanding of energy therapies and the experience the Reiki attunement process.

- 2.6 identify the 7 major Chakras.
- 2.7 demonstrate proper body mechanics while performing Reiki treatments.
- 2.8 demonstrate record keeping skills.
