FSC 105 PORTFOLIO DEVELOPMENT

Credit Hours: 4 Lec 1 Lab 6

(Same as AJS, EMS 105)

PREREQUISITE: None

COURSE DESCRIPTION

Designed to help personnel of Law Enforcement, Fire Science and Emergency Medical Services develop a portfolio that details those prior-learning experiences that may be considered for college credit at Arizona Western College. Credit/No Credit.

1. COURSE GOALS

- 1.1 Collect and analyze materials needed to earn college credit to meet career and personal goals.
- 1.2 Have the opportunity to learn techniques used to secure positions in the world of work.

2. OUTCOMES

Upon satisfactory completion of this course, students will be able to:

- 2.1 do self-assessment in the areas of interests, abilities, values, and life style.
- 2.2 enlarge and clarify knowledge-perceptions of career fields and specific occupations.
- 2.3 prepare a portfolio of the appropriate documentation needed for the evaluation of past experiential learning equivalent to college credit.

3. METHODS OF INSTRUCTION

- 3.1 Lecture, group interaction and individual analysis
- 3.2 Participation in job searches using computer assisted techniques

4. LEARNING ACTIVITIES

- 4.1 The student will be giving several reading assignments, furnished in class
- 4.2 Lecture will be given on specified topics, i.e., the process of vocational choice, personality need theory, etc.
- 4.3 The student will explore various computer techniques to secure career information

5. EVALUATION

- 5.1 Grade will be earned by an assortment of learning activities, exams, assignments, and participation

6. STUDENT RESPONSIBILITIES

- 6.1 Under AWC Policy, students are expected to attend every session of class in which they are enrolled.
- 6.2 If a student is unable to attend the course or must drop the course for any reason, it will be the responsibility of the student to withdraw from the course. Students who are not attending as of the 45th day of the course may be withdrawn by the instructor. If the student does not withdraw from the course and fails to complete the requirements of the course, the student will receive a failing grade.
- 6.3 Americans with Disabilities Act Accommodations: Arizona Western College provides academic accommodations to students with disabilities through AccessABILITY Resource Services (ARS). 6.5 Texts and Notebooks: Students are required to obtain the class materials for the course.

6.6 Arizona Western College students are expected to attend every class session in which they are enrolled. To comply with Federal Financial Aid regulations (34 CFR 668.21), Arizona Western College (AWC) has established an Attendance Verification process for "No Show" reporting during the first 10 days of each semester.

Students who have enrolled but have never attended class may be issued a “No Show” (NS) grade by the professor or instructor and receive a final grade of “NS” on their official academic record. An NS grade may result in a student losing their federal financial aid.

For online classes, *student attendance in an online class is defined as the following* (FSA Handbook, 2012, 5-90):

- Submitting an academic assignment
- Taking an exam, an interactive tutorial or computer-assisted instruction
- Attending a study group that is assigned by the school
- Participating in an online discussion about academic matters
- Initiating contact with a faculty member to ask a question about the academic subject studied in the course
