LAS 115 CRIMINAL TRIAL PROCEDURE

PREREQUISITE: LAS 101

COURSE DESCRIPTION

Procedural aspects of the criminal trial process in Arizona state courts from preliminary proceedings through trial.

1. COURSE GOAL

Develop basic knowledge of criminal procedural issues and rules in Arizona.

2. OUTCOMES

Upon satisfactory completion of this course, students will be able to:

- 2.1 describe the preliminary proceedings in a criminal prosecution and their due process requirements.
- 2.2 compare and explain the procedural requirements for the issuance of a criminal complaint, information, or indictment.
- 2.3 prepare a criminal complaint, information, or indictment.
- 2.4 describe the rights and obligations of the state, defendant, and victims before and during a criminal trial.
- 2.5 compare and contrast the discovery rights and obligations of the state and the defendant.
- 2.6 describe the nature and scope of pretrial hearings.
- 2.7 prepare a pretrial motion.
- 2.8 describe the substantive and procedural requirements for pleas of guilty and no contest.
- 2.9 describe the stages of a criminal trial and identify common evidentiary issues.
- 2.10 prepare jury instructions.

6. STUDENT RESPONSIBILITIES
