LAS 220 LEGAL INTERVIEWING, INVESTIGATING, AND REPORT WRITING

Credit Hours: 3 Lec 3

PREREQUISITE: LAS 100 and LAS 131

COURSE DESCRIPTION

Interviewing, investigating, questioning, documenting, and evidence analysis.

1. COURSE GOAL

Develop basic knowledge of client and witness investigative techniques.

2. OUTCOMES

Upon satisfactory completion of this course, students will be able to:

- 2.1 describe the ethical and professional responsibilities in interviewing and investigation.
- 2.2 prepare appropriate formal discovery documents for use in an investigation.
- 2.3 analyze and apply the Rules of Evidence in selected case studies.
- 2.4 demonstrate the proper use of communication skills for the investigator and interviewer.
- 2.5 as a member of a team, prepare for, conduct, and document a client and witness interview.
- 2.6 describe appropriate methods for locating and evaluating witnesses.
- 2.7 identify appropriate public and private sources of information.
- 2.8 prepare a proper written request for publicly available information from the federal, state, county, or local government.
- 2.9 prepare a proper written request for privately held information.
- 2.10 prepare a written report summarizing the results of an assigned factual investigation case study.

6. STUDENT RESPONSIBILITIES
