## LMT 107 ORIENTATION TO MASSAGE THERAPY

Credit Hours: 2 Lec: 2

PREREQUISITE: None

COURSE DESCRIPTION

An introduction of massage therapy in supportive healthcare. Included are history, benefits, and principles of professionalism, legal issues, and business considerations.

1. COURSE GOAL

Discover the basics of massage therapy as a profession and prepare for entry into the program with skills for successful completion of certification.

2. OUTCOMES

Upon satisfactory completion of this course, students will be able to:

2. identify personal interpretations of touch and their influence on professional interactions.
- 2.3 describe the historical development and the influence of events on the current development of therapeutic massage.
- 2.4 demonstrate appropriate touch in establishing and maintaining professional boundaries and therapeutic massage.
- 2.5 identify good health and personal hygiene practices.
- 2.6 demonstrate confidentiality in healthcare settings.
- 2.7 demonstrate effective communications skills.
- 2.8 demonstrate ethical decision making and critical thinking skills.
- 2.9 describe research literacy.
- 2.10 demonstrate professional record keeping with appropriate terminology.
- 2.11 define evidence-based practice.

6. STUDENT RESPONSIBILITIES

Students who have enrolled but have never attended class may be issued a “No Show” (NS) grade by the professor or instructor and receive a final grade of “NS” on their official academic record.
