THE 250 REHEARSAL AND PRODUCTION

Credit Hours: 1-3 Lec 1 Lab 3-5

PREREQUISITE: None

COURSE DESCRIPTION

This course involves participation in theatre productions. Registrants comprise the casts, technical crews, publicity, and management personnel for AWC Theatre public events. Events include guest performing artists and home productions each semester.

6. STUDENT RESPONSIBILITIES
