WLD 108 TECHNIQUES IN GAS TUNGSTEN ARC WELDING

Credit Hours: 3 Lec 2 Lab 2

PREREQUISITE: None

COURSE DESCRIPTION

Industrial practices of gas tungsten arc (TIG-Heliarc) welding.

1. COURSE GOAL

To develop in the student the fundamental knowledge and ability to perform assigned tasks as per set specifications utilizing GTAW.

Upon satisfactory completion of this course, students will be able to:

- 2.1 perform the assigned tasks through the GTAW process at a level of 55% proficiency or better.
- 2.2 identify the major features and components of a GTAW System.
- 2.3 setup and operate equipment to perform basic GTAW with an emphasis on safe weld procedures and applications.
- 2.4 explain the associated theory of GTAW with an emphasis on safe weld procedures and applications.
- 2.5 complete the AWS Level 1 S.E.N.S.E. program welder exam.

6. STUDENT RESPONSIBILITIES
